King of Eswatini28th June, 2018**AN ACT**
ENTITLED

AN ACT to amend the Dairy Act No. 28 of 1968 so as to empower the Minister to increase the penalties for offences under the Act and to empower the Board to prescribe administrative sanctions.

ENACTED by the King and the Parliament of Eswatini.

Short title and commencement.

1. (1) This Act may be cited as the Dairy (Amendment) Act, 2018 and shall be read as one with the Dairy Act, No. 28 of 1968, (hereinafter referred to as the “Principal Act”).

(2) This Act shall come into force on the date of publication in the Gazette.

Amendment of section 16.

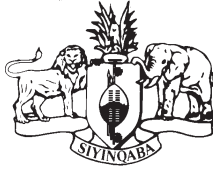
2. Section 16 of the Principal Act is amended by adding a new subsection (4) as follows-

“(4) A notice under this section may prescribe administrative sanctions to any person who fails to comply with a prescription, directive, regulation or condition of a permit or license.”

Amendment of section 31.

3. Section 31 of the Principal Act is amended by deleting and replacing the section as follows -

“31. Any person who commits an offence under this Act shall be liable, on conviction, to a fine not exceeding one hundred thousand Emalangeni (E 1 00,000.00) or to a term of imprisonment not exceeding twenty (20) years.”
