LEGAL NOTICE NO. 89 OF 2018

THE TRADING LICENSING ORDER, 1975
(Order No. 20 of 1975)

THE RESERVATION OF CERTAIN TRADES OR BUSINESSES FOR SWAZI
CITIZENS, REGULATIONS, 2018
(Under Section 20)

In exercise of the powers conferred by Section 20 of the Trading Licensing Order, 1975, the Minister for Commerce, Industry and Trade makes the following Regulations –

Citation and commencement

1. (1) These Regulations may be cited as The Reservation of Certain Trades or Businesses for Swazi Citizens, Regulations, 2018.

(2) These Regulations shall come into force on the date to be determined by the Minister in the Gazette.

Trades or Businesses to be Reserved for Swazi Citizens

2. (1) The businesses or trades listed in Schedule 1 are reserved for Swazi Citizens.

(2) A non-Swazi Citizen shall not conduct any business or trade under Swazi Nation Land.

Application

3. These regulations shall not apply to a licensee who at the time of coming into force of these Regulations is a valid holder of that license.

SCHEDULE 1

Peddler

1. The holder of a peddler license shall be entitled to carry on business while travelling on foot, or with a pack animal or carried and who carries goods for retail sales.

Hawker (each vehicle or carrier)

2. (1) The holder of a hawker license shall be entitled to carry on business as principal, agent or employee by selling or exchanging or offering or exposing for sale or exchange goods, wares, foodstuffs, produce or live animals –

(a) which the holder conveys from place to place, whether by vehicle or otherwise;

(b) in any street or at any other place accessible to the public, or from any vehicle or movable structure; or

(c) at any place away from trade/business premises in respect of which another license is held by such person.

(2) A hawker license shall entitle the holder to sell food, drinks, food other than drinks, cut flowers, ice cream, frozen suckers, frozen foods, fruits and vegetables, clothes and shoes.

(3) A holder of a license who conducts business in terms of paragraph (a), may take out many licenses in the holders name, in respect of the number of agents or employee as the licensing officer may approve, and any such agent or employee may in terms of any such license carry on business/trade on behalf of such holder if the holder is in possession of a licence to hawk, issued to such agent or employee by the issuing authority concerned, after compliance with such requirements, including the payment of any fee, as may be prescribed.

(4) If the Licensing Officer concerned is satisfied that a principal, agent or employee has failed to comply with any law relating to health requirements or health precautions, the officer may cancel the license of such an agent, principal or employee by serving notice to that effect on the holder of the license.

Produce And Handwork Vendor

3. (1) A producer and handwork license shall be required from every person who sells produce of handwork.

(2) For the purpose of this section “produce” includes eggs, home-made non-alcoholic beverages, fresh fruit and vegetables and “handwork” shall mean handwork made within Swaziland

Vendor’s Cart

4. (1) The holder of a vendor’s cart license shall be entitled to carry on business by selling or exchanging or offering or exposing for sale or exchange goods, wares and foodstuffs –

- (a) which the holder conveys from place to place, whether by cart or movable structure;
- (b) in any street or any other place accessible to the public, at any open stand or from any vehicle or movable structure.
- (c) The holder of this license shall be entitled to sell prepared food, non-alcoholic beverages, tobacco and sweets.

Street Photographer

5. (1) The holder of a Street Photographer license shall conduct such business, as a principal, or as an employee or agent of a principal, who carries on business by taking photographs of persons in any public street or other public places and inviting such persons to buy photographs.

(2)The holder of a Street Photographer license may in terms of the license also sell the photographs contemplated in paragraph (1).

Shoes Repairing

6. (1) The holder of this license shall be entitled to carry on the trade or business of repairing shoes in a General Area declared as such under this Order.

(2) For purposes of this license, “repairing” includes altering.

Dealer In Farm Produce

7. (1) A dealer in Farm Produce license holder shall be entitled to carry on the business of buying farm produce for the purpose of sale, consignment, barter or exchange, whether by auction or out of hand, and whether or not the holder dealing has a recognized place of business.

(2) Every such license, save as herein after provided, shall be issued in the name of an individual only, and shall be required by any person who conducts such business on behalf of the license.

(3) Where this license is issued to a company or partnership, the license shall also bear the name of the individual using such license.

Bakery

8. (1) A bakery license holder shall be entitled to carry on the business of making, baking or selling whether by wholesale or retail, bread, biscuits, rusks, pastry, rolls, tarts and other flour confectionery.

(2) A holder of a Bakery license may also in terms of the license –

(a) sell or offer or expose the holder's products for sale at wholesale or retail on the business premises where they are baked or made.

(b) sell and deliver the holder's products from a vehicle which the holder owns, to a holder of a license who may in terms of the license sell products, and

(c) Acquire any product referred to in paragraph 1, from another baker and deal therewith as contemplated in sub-paragraph (a) or (b).

Private Investigator or Freelancer Journalist

9. (1) A holder of a Private Investigator license shall be a person who, as principal or as representative, agent or employee of such principal, carries on business by instituting investigations, obtaining information or tracing persons on the instruction of another.

(2) A holder of a Freelancer Journalist license shall be a person who works as a writer, designer, performer, selling their work or services by the hour or by the job rather than working on a regular salary basis for one employer.

Billiard and Snooker Table Keeper

10. The holder of a billiard and snooker table keeper license shall be entitled to keep a billiard table for public use whether or not a charge is made for the right to play and such a license shall not be granted unless a certificate, issued by the police officer of the rank of sub-inspector or above, provided also that the person to which it is to be issued is of good character and has been produced to the licensing officer.

Miller (Purchasing and Sale)

11. The holder of a miller license shall be entitled to carry on business in respect of every mill by any person who carries on the trade or business of purchasing and milling, or grinding sugar cane, nuts, cotton or any seed into sugar, flour, meal or other products for sale and in the case

cereals, only for sale as a whole grain or who carries on the trade or business of milling sugar, grinding nuts, cotton or other seeds into flour, meal or other products for reward in cash or kind.

Cobbler

12. The holder of a cobbler license shall be entitled to carry on the business of making, repairing and selling foot-ware.

Blacksmith Or Farrier

13. The holder of a blacksmith or farrier license shall be entitled to carry on the business of a blacksmith and this license shall entitle the holder of the license to sell materials ordinarily used in connection with such-trade.

Eating Housekeeper (Shisanyama)

14. The holder of an Eating Housekeeper(Shisanyama) license shall be entitled to carry on the business of selling or supplying food or drink in any building, structure or premises where food or drink is sold or supplied for consumption upon the premises.

Green Grocer

15. (1) The holder of Green Grocer license shall be entitled to carry on the business of selling fresh fruit, fresh vegetables, flowers and plants.

(2) A grower of fruits, vegetables, flowers or plants, in respect of the sale of the produce when grown or cultivated by the grower, and a farmer, in respect of the sale of produce grown or cultivated by him, if such sale takes place on the land where fruits, vegetables, flowers, plants or produce, as the case may be, is or are grown or cultivated shall not be required to hold this license.

Disinfector Or Fumigator

16. (1) The holder of a Disinfector or Fumigator license shall be entitled to carry on business of disinfection or fumigating with hydro-cyanic acid gas or any other substance, which may not endanger the life or health of a human being.

(2) This license shall only be granted to an individual and issued in the holder's name and shall not confer the right on any other person to act on behalf of the holder of the license unless such holder is present and exercises supervision personally.

Debt Collector

17. The holder of a debt collector license shall be entitled to carry on business of –

- (a) collecting money as cessionary of a debt or on behalf of a creditor or undertaking to do so;
- (b) receiving money from a debtor on the understanding to pay to the creditor concerned; or

- (c) settling the debt of a debtor or undertaking to do so after such debtor has undertaken that he will pay the amount to be settled to the debt.

18. A person who is an interim curator, executor or administrator of a deceased estate or who is a trustee of an insolvent estate or the judicial manager or liquidator of a company in respect of the performance of his duties in that connect shall be exempt from the requirements of having a license.

Dealer or Speculator In Livestock

19. (1) The holder of a dealer or speculator in livestock license shall be entitled to carry on the business of buying livestock for the purpose of sale, barter, or exchange or who, as an employee of a person carrying business as a dealer or speculator in livestock conducts such business on behalf of his employer, and whether by auction or out of hand and whether or not such person has a recognized place of business.

(2) A farmer or breeder of livestock shall not require this license in respect of the sale, barter or exchange of livestock bred by him in Swaziland or purchased and resold in the course of his ordinary farming operations.

(3) Every such license shall be issued in the name of one individual only.

(4) If such license is issued to a company or partnership it shall also specify the name of the individual using it and the name of such individual may be changed by a Licensing Officer without any additional charge, upon the request of the company or partnership.

Fishmonger or Fishfrier

19. (1) The holder of a Fishmonger or Fishfrier license shall be entitled to carry on this trade by selling or offering for sale raw fish or frying or otherwise cooking, pickling, currying or subjection to any other process or preparation of fish and selling it for consumption on or off the licensed premises.

(2) The holder of a Fishmonger or Fishfrier license may in terms of the license also sell dried, salted or smoked fish.

Ice cream Parlour

20. The holder of an Ice cream Parlour license shall be entitled to carry on the business of selling, offering or exposing for sale ice cream or any other related products from any premise.

Café Keeper

21. (1) The holder of a Café Keeper license shall be entitled to carry on business of selling or supplying meals or refreshments for consumption on or off the licensed premises.

(2) A holder of a Café Keeper license may also in terms of the license sell or supply bread, meat, including cooked poultry, cooked fish, biltong, polony, sausages, bacon, eggs, butter for consumption on or off the licensed premises.

Caterer

22. (1) The holder of a Caterer license shall be entitled to carry on the business of preparing food and supplying such food, with or without drink, at any function, reception, entertainment, party or gathering of people.

(2) A holder of a Caterer license may in terms of the license also supply aerated or mineral water, cordial, syrup or other non-alcoholic beverages of similar nature consumption at a gathering referred to in paragraph (1).

Breakdown Service

23. (1) The holder of a Breakdown license shall be entitled to carry on the business of towing away motor vehicles, tractors and self-propelled machinery and self-propelled vehicles which are not motor vehicles, which have been involved in an accident or have otherwise become defective.

(2) A Breakdown license shall only be granted if the business premises have storage for such number of vehicles as the license concerned may determine.

(3) For the purpose of this item “motor vehicles” means a self-propelled vehicle which has been designed principally for the conveyance on a public road of passengers or goods or both.

Advertisement Agent/Advertising Contractor

24. (1) The holder of an Advertising license shall be entitled to carry on the business of making graphic design, painting and or locating advertising for other persons.

(2) A holder of this license may also contract for the exhibition of display in any advertisement of any description in any manner whatsoever subject to compliance with the applicable law.

(3) Any agent acting on behalf of a duly licensed advertising agent or contractor shall be exempt from the above requirements.

Take Away License

25. (1) A Take Away license holder shall be entitled to sell cooked and / prepared food, snacks and refreshments other than fresh meat, and vegetables.

(2) Operators shall be required to provide oil separators or traps for the drainage system so that cooking oil does not end up in the water system.

(3) A take –away license shall, subject to the right to use the premises for storage only, be restricted to the fixed premises specified therein.

Laundromat License

26. (1) The holder of a Laundromat License shall operate a place where the public may wash and dry their clothes in machines, or wash and iron clothes manually.

(2) A Laundromat shall be restricted to fixed premises.

(3) The Licensee shall be required to have a functional drainage of waste water.

Motor Driving School or Driving Instructor License

27. (1) The holder of a Motor Driving School or Driving Instructor license shall be entitled to carry on the business of-

- (a) instructing any person or having such person instructed in the driving of motor vehicle.
- (b) teaching any person or causing such person to be taught the rules of the road, the road traffic signs and the road signs; or
- (c) supervising any person or having such person supervised while such person drives a motor vehicle on a public road.

(2) A Motor Driving School or Driving Instructor license holder shall have business premises where any person is, for the purpose of paragraph (a) accepted or theoretically instructed.

Restaurant License

28. (1) A Restaurant License holder shall be entitled to sell snacks and refreshments and shall have a kitchen (from where food is cooked and prepared) and sitting facilities.

(2) A Restaurant license holder is entitled to prepare food for catering outside the licensed premises.

(3) The license shall entitle the holder to sell, for consumption on or off the licensed premises, fruit, vegetables, sweets, sandwiches, cut bread, butter, cakes, biscuits, pastry of all kinds, cigarettes, tobacco, matches, cream, milk, eggs, books, papers and magazines.

Petrol Filling Station License

29. (1) A Petrol Filling Station license holder shall be entitled to sell lubricants, Liquefied Petroleum Gas (domestic gas), aerated mineral water and soft drinks.

(2) The Petrol filling Station License shall be restricted to the fixed premises specified therein.

(3) Gas handling should conform to safety standards.

(4) A Petrol Filling Station License shall not be issued unless the applicant can produce proof that he has been issued with a calibration certificate in respect of all the fuel dispenser which will be used in the Petrol Filling Station.

Hair Dresser License

30. (1) The holder of a Hairdresser license shall be entitled to sell hair products and cosmetics.

(2) A hairdresser license shall be restricted to the fixed premises specified therein.

Funeral Parlour License

31. (1) The holder of a Funeral Parlour License shall be entitled to sell coffins, wreaths, flowers, grave covers and tombstones.

(2) A funeral Parlour License shall prepare corpses for burial and perform all other functions necessary for the handling of the corpse and cremation or burial.(3)The holder of a Funeral Parlour License shall subject to the right to use other premises for storage only, be restricted to the fixed premises specified therein.

Dry Clean License

32. (1) The holder of a Dry Clean License shall be entitled to operate a dry cleaning business.

(2) A Dry clean shall be restricted to fixed premises.

(3) The license shall be required to have a functional drainage system for the disposal of waste water.

Curio Shop License

33. (1) The holder of a Curio Shop License shall sell handicrafts, antiques and ornaments, including screen painted items, hand painted pictures, newspapers, magazines, journals, souvenir, greeting cards, photo films, jewellery, tie and dye products. In addition ,the holder of this license may sell flowers.

(2) Curio shops not operating within the premises of tourism enterprises shall be licensed under this Order.

Cleaning Service License

34. (1) A holder of a Cleaning Service License shall be entitled to render the service of general cleaning of premises including shops, offices and residential places for a fee.

(2) The license shall also be entitled to clean upholstery such as carpets, sofas and curtains.

(3) The holder of a cleaning Service License shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified in the license but has the option to deliver the service at the client's place.

Boutique License

35. (1) A holder of a Boutique License shall sell clothing, footwear, handbags, jewellery, designer clothes, perfumes, cosmetics, baby wear, and related accessories, for a defined market segment.

(2) A holder of a Boutique License shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified in the license.

Auctioneer's License

36. (1) The holder of an Auctioneer's license shall be entitled to sell any goods by public auction sale, sell out of hand; any such goods which were offered for sale by him at such auction sale but remain unsold.

(2) Any employee of the holder of an Auctioneer's License whose name is endorsed in such license shall not qualify to bid in the auction sale.

- (3) No judicial sale shall be conducted under an Auctioneer's License.
- (4) For security purposes, there should be proof of permission to auction from the police before the auctioning takes place.
- (5) The requirements in this Regulation shall not apply to—
 - (a) A messenger of the court or his deputy or a sheriff or his deputy or any other duty authority officer of the court or a Pound Master when acting in the course of his duty.
 - (b) Any person appointed to sell movable or immovable property for or on behalf of the state or local authority, when he acts in terms of such appointment.
 - (c) Any person acting in terms of an appointment to sell by auction on behalf of society or any association for the promotion of agriculture or the improvement of livestock or poultry at agriculture show or market held by such society or association.

Grocer

37. (1) The holder of a Grocer license shall be entitled to carry on the trade or business of selling, bartering, exchange, or offering for sale, groceries only.
- (2) A holder of a general dealer's license who carries on the trade or business of a general dealer in the licensed premises shall not require this license.
- (3) For purposes of this paragraph, groceries means all foodstuffs except fresh meat and fish and includes non-alcoholic drinks, soap, candles, paraffin, matches cigarettes and tobacco.
- (4) Notwithstanding the provision of sub regulation (3) above, if the trade or business operated under this license is situated in a rural area, "groceries" also includes patent medicines, stationery, torch and radio batteries, razor blades, methylated spirits, benzene, paraffin lamps, shoelaces, toilets paper, locks and keys and pocket knives.

Spaza Phone Services License

38. (1) The holder of spaza phone service or mobile spaza phone services license shall provide telephone services to the public for a fee or reward.
- (2) A spaza phone service or mobile spaza phone services license shall be restricted to the fixed premises specified therein.
- (3) The license shall sell SPTC cards, MTN cards, Swazi Mobile cards, any other mobile network cards registered in Eswatini, sweets and snacks only.

Dealer In Used or Second Hand Goods

39. The holder of a Dealer in used or second hand goods license shall be entitled to carry on the trade or business in or from licensed premises by buying, selling or exchanging one or any of the following used goods-

Clothing, footwear, timber, building bricks or blocks, building material or accessories, worn out machinery, drums, tins, bottles, packing-cases-boxes, crates or other containers, metal, rags, bags, paper or other waste materials.

Cinematographic Film Exhibitor

40. The holder a Cinematographic Film Exhibitor license shall be entitled to carry on the business of showing or exhibiting cinematographic films for payments or reward.

Dealer In Household, Patent And Proprietary Medicine

41. (1) The holder of this license shall be entitled to carry on the business of selling or supplying herbal medicine, household medicine, or patent and proprietary medicine by retail.

(2) For the purposes of paragraph (1)

(a) “household medicine” means any medicine or medicinal product or preparation which is not a herbal medicine or any medicine contemplated in sub-paragraph (b) and which is manufactured and sold under a recognized and well known name; and

(b) “patent and proprietary medicine” means any medicine-

(i) protected under current letters patent;

(ii) prepared or purported or professed to have been prepared from some or other secret formula;

(iii) prepared or purported or professed to have been prepared by some secret or occult, whether or not the formula is or is professed to be secret;

(iv) sold under a name or trade-mark specially registered in respect thereon, or

(v) sold under any description, which implies or indicates proprietary rights.

(3) The requirements above shall not apply to a holder of a Pharmacy License

Dairy or Dairy Farm

42. (1) The holder of Dairy or Dairy Farm license shall be entitled to carry on business by selling or distributing milk products and –

(a) sterilizing, pasteurizing it or subjecting it to any other from hot treatment or cooling it; or

(b) processing it into any milk product or composite dairy product; or

(c) placing such milk, milk product or composite dairy products is distributed and sealing such containers.

(2) A holder of a Dairy or Dairy Farm license may in terms of the license also sell, distribute or deliver milk, any products, or composite dairy product on or off the licensed premises. For the purpose of this, paragraph “milk product” means cream, separated milk, sour milk, buttermilk,

cultured mild or cultured butter milk which is produced from land of which the applicant is the owner, lessee or occupier, provided such trading is not carried on by such person through an agent, other than employee of such person.

Driller License

43. The holder of a Driller license is entitled to carry on the business of drilling water for payment or reward.

Barber

44. The holder of a barber license shall be entitled to carry on the business of shaving, cutting, washing, waving, and straightening or otherwise treating the hair and or beard of any other person.

Supermarket/Chain Store License

45. (1) The holder of a supermarket or chain Store License shall sell food items (groceries) and household goods. In addition, the holder is entitled to sell unscheduled or patent medicines, cosmetics, toiletry and reading matter such as newspapers.

(2) A Supermarket or Chain Store License requires a minimum floor space of 1000 square meters.

(3) A Supermarket or Chain Store License shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified in the license.

Furniture Shop License

46. (1) The holder of a Furniture Shop License shall sell movable household goods and electronic equipment.

(2) A furniture shop shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified in the license.

Business Broker, Estate Agent and Employment Agent

47. The holder of a business broker, estate agent and employment agent license shall be entitled to carry on the business of –

- (i) Negotiating bargains or contracts between persons in matters of business, trade or commerce, including sales or other dispositions of movables or immovable property for a remuneration commonly called commission or brokerage; or
- (ii) Executing or undertaking any agency, including the letting of houses or other fixed property for a commission; and
- (iii) Screening and recruiting personnel for employment for individuals or organization for a commission.

Car Rental Service License

48. (1) The holder of a car rental services licensee shall rent out cars and services to the public for a fee or reward.

(2) A car rental service licensee shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified therein.

(3) The licensee shall have the option to deliver the rented car and services at client's place.

Kennel Or Pets Boarding Establishment Or Salon

49. The holder of a Kennel or Pets Boarding Establishment or Salon license shall be entitled to carry on business by –

- (i) Keeping two or more dogs for the purpose of breeding and selling dogs or offering dogs for sale; or
- (ii) Keeping dogs for the purpose of training them or hiring them out as watchdog; or
- (iii) Providing boarding for dogs and pets; and
- (iv) Giving beauty treatment to dogs or pets by clipping, washing or brushing or by attending to their nails or teeth.

Livery Stable Or Riding School Keeper

50. The holder of a Livery Stable or Riding School Keeper license shall be entitled to carry on business by keeping horses or any other member of the equine family for the purpose of –

- (i) Hiring them out for riding or any other work, or
- (ii) Using them to give riding lessons.

Manufacturer

51. (1) The holder of a Manufacturer license shall be entitled to engage in the production of a finished article from raw materials or printing from combination of other articles and materials.

(2) This license shall not be required under this item for the sale of –

- (i) Produce or handwork grown, produced or made within Eswatini when sold by person who has produced, grown or made such article.
- (ii) Produce on handwork covered by any other subsisting license issued under this order
- (iii) Produce grown or produced within Eswatini and any handwork when sold by any person within a Swazi Area.

Motor Vehicle Attendant

52. The holder of this license shall be entitled to carry on business in a street or other public place by allocating or offering to attend to or take care of a parked motor vehicle.

Temporal Or Special License

53. A licensed person who wants to sell any item in respect of which that person is duly licensed under these regulations, shall apply for this license in order to carry on the trade or occupation for which he is licensed at any exhibition, agricultural or stock show or at any place within Swaziland.

Motor Vehicle License

54. (1) The holder of a Motor Vehicle license shall be entitled to sell petrol, oil, tyres and other motor accessories other than motor cars, motor cycles or other self-propelled vehicles.

(2) The license holder shall be entitled to carry on the business of repairing, receiving, stabling or storing motor vehicles, motor cycles or other mechanically propelled vehicles for payment or reward.

Pharmacist / Chemist And Apothecary

55. (1) The holder of this license shall be a person who practices as a pharmacist, who sells and supplies by retail any drug or medicine and who compounds and dispenses prescriptions.

(2) A holder of this license may in terms of the license also sell, offer or expose for a sale medical, surgical, orthopedic, photographic appliances, apparatus requisites, toilet requisites and such other articles of a like nature as are customarily dealt in by a chemist or druggist.

Hire Service License

56. (1) The holder of a Hire Service License shall hire out goods and services for a fee.

(2) A Hire Service License holder shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified therein.

(3)The license shall have the option to deliver the goods and services hired at the client's place.

General Clothing License

57. (1) The holder of a General Clothing License shall sell things including clothing, footwear, handbags, jewellery or cosmetics.

(2) A General Clothing License shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified in the license.

(3) This requirement shall not apply to a person who carries on trade by selling, exchanging or offering or exposing for sale or exchange –

- (a) Newspaper, including any printed matter, not being a bound volume.

- (b) A programme of a performance of any nature, whether it is written, type written, printed or produced in any other manner.
- (c) Produce of land of which he is the owner, lease or occupier, provided such trading is not carried on by such person through an agent, other than employees of such person.

General Dealer's License

58. (1) The holder of a General Dealer's License shall trade in any goods other than those covered under Fresh Produce, Petrol Filling Station, Motor Dealer's or Restaurant licenses.

(2) A General Dealer Licensee may sell unscheduled drugs or medicines, which do not require a doctor's prescription, Liquefied Petroleum Gas (domestic gas) and paraffin.

(3) A General Dealer's Licensee shall, subject to the right to use premises for storage only, be restricted to the fixed specified in the licence.

(4) The storage and handling of gas should conform to the safety standards.

(5) The holder of a General Dealer's license shall be entitled to carry on business in a shop, store or place where goods, wares, merchandise produce or livestock are sold, bartered or exchanged or offered or exposed for sale, where the trade or business so carried on is not covered by any other license issuable under these regulations or any other law.

(6) This requirement shall not apply to a person who is –

- (i) A farmer or market gardener in respect of the sale of product raised or grown by himself.
- (ii) A manufacturer (as hereinafter defined) in respect of the sale of goods of the sale of goods manufactured or produced by him within Eswatini, except in respect of the sale of such goods by retail from a shop, store or fixed place;
- (iii) Any person licensed as a butcher, baker apothecary or fresh dealer, in so far as any dealings to that person are covered by a license or licenses held by him.
- (iv) Any person licensed to sell intoxicating liquor in respect of dealings covered by that license.
- (v) Any builder, contractor, artisan or any other person who suppliers materials or fixtures in fulfillment of his contract to do any work or as part of work done or who sells to order only the product of his own skilled labour.
- (vi) Any person who, being licensed under the Order to sell any particular articles or things, sells only those particular articles or things.
- (vii) Any mission school or other educational institution in respect of the sale of goods produced or manufactured by the scholars or inmates of any such mission, school or institution in the ordinary course of their education.

- (viii) Any school or other educational institution, in respect of the sale of books, writing materials or other educational apparatus to students or to parents or to guardians of students attending such school or education institution.
- (ix) Any mission in respect of the sale of religious books to bona fide adherents of such mission.

Butchery

59. The holder of a Butchery License shall be a person who carries on business / trade by –
- (a) Selling, offering or exposing or exposing for sale raw meat in, on or from the trade/ business premises or
 - (b) Taking any order for the delivery of raw meat from his trade / business premises
 - (c) A holder of a Butchery License may also in terms therefore –
 - (i) Make sausages, hashbrowns, polony and biltong and other meat products.
 - (ii) Sell, offer or expose for sale and take orders for delivery from the trade / business premises sausages, hashbrowns, polony, biltong, offal, ham, bacon frozen or preserved meat.
 - (iii) Render fat from animals slaughtered by him or from carcasses purchased by him: and
 - (iv) Cure the hides and skins of animals slaughtered by him.
 - (v) For the purpose of this item “meat includes the flesh of poultry, but not members of the equine family.

Workshop License

60. (1) The holder of a Workshop license shall be restricted to the fixed premises specified therein.

(2) Where the Workshop license holder repairs/ services automobile engines of any kind, he shall build a wash bay and an oil separator so that the water that is disposed of into the environment is not polluted with oil from the engine.

Repairing means replacing a worn out part, maintaining and serving the item to a reliable working condition.

Travel Agent

61. (1) The holder of a Travel Agent license shall be entitled to carry on the business of (travel agent) receiving orders or booking or journeys or passages by land, sea or air, otherwise than by transport operated by himself.

(2) A holder of a Travel Agent license may in terms of the license also sell or supply overnight bags, travel books and brochures.

(3) The Travel Agent license shall be restricted to the fixed premises specified therein.

Dealer In Aerated Or Mineral Water Manufacturer

62. (1) The holder of a Dealer in Aerated or Mineral Water Manufacturer license shall be entitled to carry on business, including a person licensed to sell intoxicating liquor, who carries on the business by selling or supplying on the business on premises, aerated or mineral water, cordial, syrup or other beverages of a similar nature, whether mixed or unmixed with any others, and whether for consumption on or off the trade premises.

(2) A holder of this license may also in terms of the license sell tobacco in any form and matches.

Physical Culture, Health Or Beauty Salon

63. A Physical Culture , Health or Beauty Salon license shall be required by a person who carries on business / trade by maintaining a place where –

- (a) Facilities for, or institution or guidance in beauty therapy, physical culture or fitness or posture improvement are provided.
- (b) Turkish bath or message or sauna or infra-red treatment is provided.

Photographic Studio

64. (1) The holder of a Photographic Studio license shall be entitled to carry on the business of taking photographs, printing, developing, enlarging of films or framing of photographs.

(2) The holder of a Photographic Studio license may in terms of the license sell and / or expose for sale the photographs contemplated in paragraph 1 and photographic equipment and accessories.

Bookshop License

65. (1) A Bookshop License holder shall be entitled to sell books, stationery, cards, magazines, newspaper, computer consumables, calculators, educational films, journals, toys and educational toys.

(2) A Bookshop license holder shall, subject to the right to use other premises for storage only, be restricted to fixed premises specified in the license.

Builder And Contractor

66. A Builder and Contractor license holder shall be entitled to carry on the business of undertaking building or construction work.

Cinema / Theatre

67. (1) A holder of a cinema and theatre license shall be entitled to carry on the business of showing or exhibiting motion pictures, and may charge an admission fee from spectators.

(2) The holder of this license shall also be entitled to sell refreshments, confectionery, cigarettes, tobacco, matches provided that such sales shall be conducted only during the show time.

Street Vendor

68. (1) A Street Vendor license shall be required in respect of a person engaged in selling, in any street, road, open place, whether as principal, agent or employee.

(2) This license shall be required from any person who personally or through an agent or employee offers goods for sale from a wheel borrow or hand cart from a bicycle or from a tray or other receptacle within any village or urban area.

(3) Provided that this license shall only be issued to a person duly licensed under this order as a bake or eating house keeper or a General Dealer or restaurant, refreshment or tea-room keeper and shall permit the sale within the village or urban area in which the holders business is situated of such non-alcoholic drinks.

Accommodation Establishment

69. (1) An Accommodation Establishment license shall be issued to a person who carries on business by providing other persons with accommodation and one or more meals per person per day, at daily, weekly, monthly or other periodic charges.

(2) A person provides accommodation in terms of this item where such person –

- (a) Provides accommodation with one or more meals per person per day and who has not more than 8 beds available; or
- (b) Provides accommodation in rooms without meals and who has not more than 4 rooms available for letting; or
- (c) Provide as accommodation one flat without meals;

(3) For the purpose of this Regulation –

- (a) “Accommodation” means sleeping or lodging facilities provided in a hotel, motel or boarding house or flats or rooms, which are let, furnished or unfurnished.
- (b) “Room” means any room without a kitchen; and
- (c) “Flat” means any room with a kitchen (block of flats)

(4) A holder of this license shall be entitled to provide parking space on the business premises exclusively for the vehicles of residents or employees of, or visitors to the accommodation establishment and wash or dry-clean linen, carpets, floor rugs, blankets, curtains or any other domestic fabrics of the accommodation establishment as well as the clothing of the resident and employees.

Hardware License

70. (1) The holder of a Hardware license shall not sell Liquefied Petroleum Gas (domestic gas).

(2) The holder of a Hardware License shall be entitled to sell tools, camping and building and building materials.

(3) A Hardware License shall, subject to the right to use other premises for storage only, be restricted to the fixed premises specified therein.

Dealer Motor Vehicle

71. (1) A Dealer Motor Vehicle license shall be required from every person, in addition to any other license held by him, who carries on the trade or business of selling, barter, exchange, or offering or exposing for sale, barter or exchange any motor car, motor cycle or other mechanically propelled vehicle.

(2) The holder of this license may in addition, sell on the premises:-

(a) Tyres and other motor accessories other than petrol and oil and

(b) Electrical appliances for motor vehicles.

Distribution License

72. (1) The holder of a Distributor's license shall sell general merchandise in bulk to licensed traders.

(2) A Distributor shall distribute nationwide, from a warehouse located in the jurisdiction of the issuing Licensing Officer.

Management Consultant

73. The holder of a Management Consultant license shall be entitled to advise individuals and organizations in any technical or managerial skill for payment or reward.

Proprietor Of A Bone Sterilising And Milling Plant

74. The holder of this license shall be entitled to purchase or otherwise acquires animal bones, hones or hoofs, or any product of the license, whether sterilized or otherwise, for the purpose of exporting them, or for the purpose of re-selling sterilized bones, horns or hoofs or any product of the license.

Departments Store License

75. (1) The holder of a Department Store license shall sell different categories of goods in different departments of items under one roof except vehicle, petrol, diesel, paraffin and Liquefied Petroleum Gas (LPG) – (domestic gas).

(2) The different categories of goods to be sold shall be listed on the license.

(3) The total floor area for the store shall be a minimum floor space of 2500 square meters.

(4) A holder of a Department Store license shall, subject to the right to use other premises for storage only, be restricted to the fixed specified in the license.

Dealer In Wholesale

76. (1) The holder of a Dealer in Wholesale license shall be entitled to carry on the business of selling, exchanging, offering or exposing for sale or exchanging goods, wares, petrol or petroleum products, foodstuffs, produce (or live animals) only in shops and other trade / business to be retailed by such shops and other businesses.

(2) A holder of this license shall, subject to right to use other premises for storage only, be restricted to the fixed premises specified in the license.

(3) The holder of this license shall only sell to retail such goods as he is entitled to sell under his license and such goods as the retailer is entitled to purchase for his retail business / trade under the retail's license.

(4) The term retail" for the purpose of this regulation shall mean a licensed trader in those goods and persons exempted under (f) here under. It shall in no event be construed to mean any member of the public, national or foreign, who is not a holder of any such license.

(5) A holder of this license shall not be a holder of any license to trade in retail.

(6) The exemptions provided for under Item 58 in respect of a General Dealer's license shall also be applicable to this item.

Agent Of A Firm Not Resident Or Carrying On Business In Eswatini

77. (1) A license for an Agent of a Firm not resident or carrying on Business in Eswatini is required by a person who, whether on a commission basis or for direct payment or for compensation in any form whatsoever, in any way advertise or holds himself out as the authorized representative or agent of any manufacturing or trading establishment not resident not carrying on business in Eswatini or who, whether as principal, agent, or employee of any manufacturing or trading concern not resident or carrying on business in Eswatini actually invites, solicits, canvasses or accepts an order for the sale or supply of goods by such a nonresident manufacturing or trading establishment to persons in Eswatini.

(2) A person granted this license shall also be entitled to supply or deliver goods to persons in Eswatini in respect of orders placed with the non-resident enterprise provided that the holder of an Agent's License shall only supply goods in bulk or in wholesale quantities to persons licensed as Manufacture's or Distributors or Dealers in Wholesale.

(3) This license shall not be required from-

(a) a person who is already licensed to trade as a Manufacturer, Distributor, Dealer in Wholesale; or

(b) any other licensed person engaged in the sale or supply of goods where such goods are purchased and resold in the ordinary course of his own licensed business: -

provided that where the person supplying the goods is a non resident manufacturing or trading establishment that is not licensed this Item, the licensed person must obtain the prior written authorization of the Minister.

(4) The Licensing Officer shall endorse on each license the full particulars of each establishment represented by the agent and the full particulars of licensed persons to be supplied by the non-resident trading establishment, provided that where a license holder wishes to assume agency for additional products he shall obtain the prior written approval of the licensing officer.

(5) If during the currency of a license the holder is unable to make use of his license, the license may, on application to the Licensing Officer in the manner prescribed, be transferred to another person on payment of the prescribed fee.

Car Wash License

78. (1) The holder of a Car Wash license shall be authorized to clean or wash automobiles and their accessories for a fee.

(2) A car washing or cleaning process can be auto mechanical or manual.

(3) The licensee or his agents shall issue a reference number or receipt to any motorist who leaves his automobile for cleaning.

(4) The car wash shall be restricted to the premises specified in the license.

(5) The license shall be required to have a functional drainage system for the disposal of soiled water.

(6) The licensee shall be required to build an oil or water separator trap so that the water is disposed of into the environment is not polluted with oil from the automobiles.

(7) The licensee shall provide a clear and identifiable bay.
